### **AAUS Instructor Renewal 2015**

Attention AAUS Instructors! It is time for your annual AAUS-ITI Instructor Renewal. You should have already received a renewal package (paper and/or electronic) from ITI. You must renew as an Instructor with International Training (ITI) to maintain status as an AAUS Instructor and to be able to register and certify AAUS divers.

*Paper renewal-* if you received a paper renewal package, you can complete the necessary information and submit the annual instructor renewal fee (\$160) via snail mail.

*Online renewal-* if you did not receive a paper renewal package, or if you prefer to renew online, you may complete this process on the ITI-SDI/TDI website ([www.tdisdi.com](http://www.tdisdi.com)). To do so, login to your Instructor Profile, and then choose 'Tools', 'Renew Membership' from the menu bar. Complete the necessary information and submit the annual instructor renewal fee (\$160) online with a credit card.

#### *Facility Renewal-*

As an AAUS instructor you must submit a paper [Facility Renewal Form](#) if you are the primary instructor/facility administrator at your AAUS facility but a fee\* will not be charged this year.

If you are an AAUS instructor and the primary instructor/facility administrator at an SDI/TDI Training facility, you must submit a separate paper [Facility Renewal Form](#) for that SDI/TDI training facility but a fee\* will not be charged this year.

*\*A facility renewal fee is only required if you are an AAUS instructor and the primary SDI/TDI instructor/facility administrator at an industry/retail facility.*

### **AAUS Strategic Planning meeting**

The AAUS Strategic Planning Committee\* recently met at the Boone Conference Center on Catalina Island for a facilitated three-day workshop and planning session to reaffirm, refine, and refocus the Academy's vision, mission, and goals, and to direct the Board's activities for the next five years. This meeting followed a year-long process of soliciting and analyzing input from membership and stakeholders (results of [survey 1](#) and [survey 2](#)). Based on this input and the outcomes of the strategic planning session, the current Board does not anticipate a major shift in its purposes and goals within the next five years; the strategic planning process identified many of the same issues as previous Boards, and the current plan is built upon and strengthened by these earlier efforts.

The primary pillars or goals identified by the planning committee are as follows. The current order does not imply prioritization.

Ensure Scientific Diving Program Quality Control, through continued vetting and implementation of the Organizational Member Scientific Diving Accreditation Program, improving understanding and communication of AAUS diving standards, and development of improved program management tools.

Improve Collaboration between the AAUS and Stakeholders, through expanding member services and increasing communication.

Promote Scientific Diving Education, through enhanced certification of divers, development of a certification process for DSOs, adding value to the Symposium, utilizing a wide range of media, and maintaining the AAUS scholarship program.

Ensure AAUS Revenue Stream and Resources through a variety of means, including facilitating the function and presence of the AAUS Foundation, securing external funding, reviewing Organizational Member and Individual Member dues, and increasing number of individual members.

Ensure Efficient Operations of the AAUS, through establishing a full-time benefitted position for the Office Manager.

Advocating for the Scientific Diving Community, by maintaining and distributing statistics and representing the interests of scientific diving in the legal/regulatory community.

The committee also identified strategies, timelines, and individuals who will spearhead these efforts. The full Strategic Plan will be vetted through the Board of Directors, who will cost out and prioritize the different initiatives. The plan will be finalized at the April meeting of the Board in Boston in April 2015. Following the meeting, the plan will go out to membership for a 60-day comment period, after which the Board will make any necessary additions or changes. Throughout this process the Board will continue working to refine and revise the plan based on member input, and we will have a full five-year plan in place for presentation to the membership at the AAUS Symposium in Key West in September 2015.

### **OSHA vs. Landry's**

The AAUS Board of Directors has recently received two inquiries, one from the Pacific Northwest DSOs group and one from Landry's Aquarium, regarding an AAUS Organizational Member and pending OSHA litigation.

In response to these inquiries the AAUS BoD has initiated the following process:

1. 2/19/15: Sent acknowledgement to both groups stating we are aware of the situation and it is under active consideration.
2. Continuing factfinding process and reaching out to stakeholders to determine the best course of action.
3. Advisory Committee consisting of past AAUS Presidents tasked with evaluating specific responses and making a recommendation to the BoD.
4. The BoD will evaluate input and develop an appropriate response. Target date: May 2015.

### **Rebreathers and Scientific Diving Training Workshop**

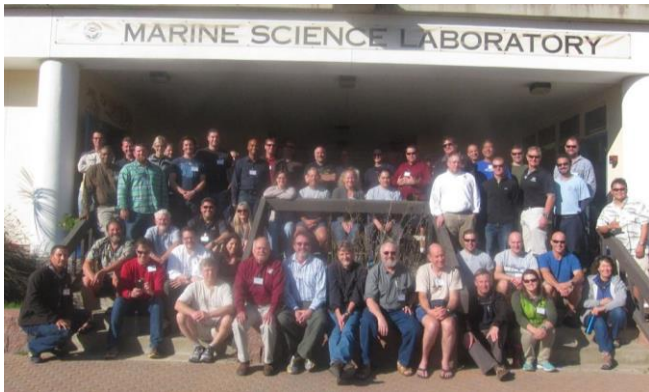

The topics covered and the input from the 50+ participants exceeded expectations and continued to strengthen the foundation for the use of this technology within the scientific diving community. The guidance information generated from the meeting will include recommendations for future initiatives to address a number of clearly important topics that could not be resolved in this forum.

While I have been given the credit for initiating this most recent effort regarding rebreathers in scientific diving, I want to acknowledge there were others on the organizing team who, in my opinion, did much more than me to make this program a success. Thank you also to the attending participants for your questions and insights during the training, your willingness to engage during the straw-man session, and for your quick and timely feedback when the draft straw-man results are circulated for review and comment.

### **Update on Pressed Steel Tanks (PST)**

DEMA has received numerous calls regarding the impending expiration of the Special Permit from the US Department of transportation (DOT) under which Pressed Steel Tanks were produced. The Special Permit was issued in 2011 and expired on January 31, 2015. DEMA has been in contact with the DOT and, working with Professional Scuba Inspectors ([www.pscylinders.com](http://www.pscylinders.com)), has obtained a copy of the NEW Special Permit which expires in 2018. This means that all PST tanks with the neck stamped with SP9791 or E9791 which are visually inspected and within hydrostatic test date are valid and may be filled (or hydrostatically tested as needed).
